In view of the observance of social distancing under the Enhanced/General Community Quarantine, the NTA-BAC shall adopt an **ON LINE** acceptance of your Eligibility/Technical/Financial Documents, in "PDF" format, to be submitted **on or before 10:00 A.M. of 05 June 2020** through the e-mail address: priscillaesguerra300@yahoo.com. Prospective Bidders may likewise submit their bid documents through recognized courier, provided, that the same should be actually stamp-received by the NTA on or before the said date and time. The date and time of receipt of the bid documents shall be the basis of accepting bid documents. No late submissions shall be opened/entertained.

The following documents shall be submitted simultaneously in two (2) separate file folders, as follows:

1. **File Folder 1 with file name: "Eligibility/Technical Documents";**
 - PhilGEPS Certificate of Registration;
 - Statement of All Its Ongoing Government and Private Contracts, including contracts awarded but not yet started, if any;
 - Sworn Statement Identifying the Bidder's Single Largest Completed Contracts (SLCC), the prospective bidders must have a single largest completed project of at least 8-floors/storey building, including mezzanine, supported by copies of the Notice of Award, Notice to Proceed, Contract and Certificate of Completion;
 - Valid PCAB License: General Engineering with Structural Demolition or General Building with Structural Demolition;
 - NFCC computation in accordance with ITB Clause 5.5; and
 - Bid Securing Declaration or in any form such as bank draft/guarantee or surety bond
 - Other documents required in **Bid Bulletin 2020-01A**
2. **File Folder 2 with file name: "Financial Documents":**
 - Required Financial Bid Form/s and any other document related to the financial component

Please take note that the submission of only one file folder without the second file folder or submission of unreadable/corrupted file shall be automatically disqualified. It is the bidder's responsibility to check whether their bid documents are complete and duly received by the NTA.
