SUPPLY AND DELIVERY OF POULTRY FEEDS FOR THE GULAYAN AT MANUKAN SA BARANGAY (GMB) PROJECT CY 2024

1. The National Tobacco Administration-Isabela Branch (NTA Isabela), through its Corporate Operating Budget, intends to apply the total sum of One Million One Hundred Twenty-Five Thousand Nine Hundred Pesos (PhP 1,125,900.00) being the ABC to payments under the contract for the project: "Supply and Delivery of Poultry Feeds for the Gulayan at Manukan Sa Barangay (GMB) Project CY 2024" (PB-ISA-2024-001).

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The NTA Isabela now invites bids for the above Procurement Project. Delivery of the Goods is required by fifteen (15) calendar days, from receipt of the Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipts of bids similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from NTA Isabela and inspect the bidding Documents at the address given below during 8:00 AM to 5:PM, except Saturdays, Sundays, Regular Holidays, and Declared Non-Working Days.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on SEPTEMBER 19, 2024 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPBB, in the amount of PhP 5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through e-mail, thereafter, verified by the BAC Secretariat.
- 6. The NTA Isabela will hold Pre-Bid Conference on **SEPTEMBER 27, 2024 at 10:00 AM** at NTA office and/or through video conferencing or webcasting via Microsoft Teams, as the case maybe, which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before OCTOBER 7, 2024 at 5:00 PM. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated ITB Clause 14.
