- 4. The Omnibus Sworn Statement² (for ABC's above Php 50k) (GPPB-prescribed forms), Income/ Business Tax Return3 (for ABC's above Php 500k) will also be required to be submitted.

- 6. The NTA reserves the right to accept or reject any quotation prior to contract award, without thereby incurring any liability to the affected interested parties.
