- The Omnibus Sworn Statement² (for ABC's above Php 50k) (GPPB-prescribed forms), Income/ Business Tax Return³ (for ABC's above Php 500k) will also be required to be submitted.
- 5. Quotations must be delivered to the address below on or before October 18, 2024, at 5 P.M.
- 6. The NTA reserves the right to accept or reject any quotation prior to contract award, without thereby incurring any liability to the affected interested parties.
