A copy of your Business/Mayor's Permit1, PhilGEPS Registration Number, and Philippine Contractors Accreditation Board (PCAB) License are also required to be submitted along with your signed quotation/proposal. A valid Certificate of PhilGEPS Registration (Platinum Membership) may be submitted in lieu of the Mayor's/Business Permit.
- 4. The Omnibus Sworn Statement<sup>2</sup> (for ABC's above Php 50k) (GPPB-prescribed forms), Income/ Business Tax Return<sup>3</sup> (for ABC's above Php 500k), and Net Financial Contracting Capacity (NFCC) (for ABC's above Php 500k) will also be required to be submitted.
- 5. Quotations must be delivered to the address below on or before October 24, 2024, at 5 PM.
- 6. The NTA reserves the right to accept or reject any quotation prior to contract award, without thereby incurring any liability to the affected interested parties.
