BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION NO. PB 2024-01

WHEREAS, during the Opening of Bids for the Project: "Supply & Delivery of Fertilizers, CPAs and Suckercides Requirements for Use in IFOIGAP-Tobacco (TCGS) 2024-2025 in Regions I, II, and CAR" with Contract ID No. PB 2024-01, conducted on 21 October 2024 at 10:00 A.M., with Diamond Kim Enterprises, the lone bidder, passed the Eligibility and Technical Documents. Hence, the BAC opened the Financial Envelopes and tendered a bid offer of \$\mathbb{P}\$ 58,749,453.00 which is lower than the Approved Budget for the Contract (ABC) of \$\mathbb{P}\$ 62,155,008.00, and accordingly, was declared as the Eligible Bidder with the Single Calculated Bid (SCB);

WHEREAS, on 22 October 2024, the BAC conducted a detailed evaluation as to the completeness of the bid, technical specifications, and arithmetical computation, and Diamond Kim Enterprises passed the said evaluation;

WHEREAS, on 29 October 2024, Diamond Kim Enterprises was subjected to and passed the Post Qualification, thus was declared as the Eligible Bidder with the Single Calculated and Responsive Bid (SCRB);

PREMISES CONSIDERED, the Bids and Awards Committee issues this Resolution, pursuant to Section 37.1.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184:

"BE IT RESOLVED, as it is hereby RESOLVED, that the NTA BIDS AND AWARDS COMMITTEE respectfully recommends to the Honorable Administrator and CEO, the award of the Contract for the "Supply & Delivery of Fertilizers, CPAs and Suckercides Requirements for Use in IFOIGAP-Tobacco (TCGS) 2024-2025 in Regions I, II, and CAR" with Contract ID No. PB 2024-01 to Diamond Kim Enterprises with the Single Calculated and Responsive Bid (SCRB), in the amount of Fifty-Eight Million Seven Hundred Forty-Nine Thousand Four Hundred Fifty-Three Pesos (** 58,749,453.00).



CONTRACT AGREEMENT

THIS AGREEMENT made on the following by and between NATIONAL TOBACCO ADMINISTRATION, with office address at 11th Floor The Upper Class Tower, Quezon Avenue corner Scout Reyes St., Barangay Paligsahan, Quezon City, hereinafter called the "Entity" of the one part, and DIAMOND KIM ENTERPRISES with office address at Brgy. Buenlag, Mangaldan, Pangasinan, hereinafter called the "Supplier" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the "Supply & Delivery of Fertilizers, CPAs and Suckercides Requirements for Use in IFOIGAP-Tobacco (TCGS) 2024-2025 in Regions I, II, and CAR" (PB 2024-01), and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Fifty-Eight Million Seven Hundred Forty-Nine Thousand Four Hundred Fifty-Three Pesos (P 58,749,453.00) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - II. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- III. Performance Security/ Performance Securing Declaration;
- Notice of Award of Contract; and the Bidder's conforme thereto; and
- V. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
