WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the "Supply & Delivery of Thirty-Two (32) Units of Midrange Desktop Computers for the Use of the NTA Central Office and Branch Offices" (PB 2024-02), and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Nine Hundred Four Thousand Ninety-Six Pesos (P1,904,096.00) hereinafter called "the Contract Price".

- IV. Notice of Award of Contract; and the Bidder's conforme thereto; and
- V. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
