WHEREAS, pursuant to the 2016 Revised Implementing Rules and Regulations of the Republic Act No. 9184 (The Government Procurement Reform Act), the NTA Bids and Awards Committee (BAC) caused the PhilGEPS posting through Public Bidding of the project: "Supply & Delivery of Seventeen (17) Units of Midrange Laptop Computers for the Use of the NTA Central Office and Branch Offices" on November 09, 2024, with an Approved Budget for the Contract (ABC) in the amount of ₱ 1,275,000.00;

WHEREAS, on November 19, 2024, the BAC conducted a Pre-Bidding Conference which was attended by the (3) interested bidders, to wit:

 Pronet Systems Integrated Network Solution, Inc.
 Nuntius Electronics, Inc.

WHEREAS, during the Opening of Bids for the Project: "Supply & Delivery of Seventeen (17) Units of Midrange Laptop Computers for the Use of the NTA Central Office and Branch Offices" with Contract ID No. PB 2024-04, conducted on December 03, 2024 at 10:00 A.M., the following prospective bidders submitted their bid proposals, to wit:

Nuntius Electronics, Inc.
 Pythos Technology Philippines, Inc.

WHEREAS, the prospective bidders successfully passed the Eligibility and Technical Document evaluations using the Pass/Fail criterion. Accordingly, the BAC proceeded with the opening of the Financial Envelopes and tendered the following financial proposal:

WHEREAS, Pythos Technology Philippines, Inc., offered the amount of ₱1,083,750.00 which is lower than the Approved Budget for the Contract in the amount of ₱1,275,000.00;

WHEREAS, the Bid Evaluation scheduled on December 04, 2024, the BAC conducted a detailed evaluation as to the completeness of the bid, technical specifications, and arithmetical computation, and Pythos Technology Philippines, Inc. passed the said evaluation, and accordingly, was declared as the Eligible Bidder with the Lowest Calculated Bids (LCB);

WHEREAS, the BAC conducted a Post Qualification process via a virtual meeting, which took place on December 16, 2024, with the BAC Chairperson, Secretariat and the Technical Working Group at the Pythos Technology Philippines, Inc., No. 3 Mountain Drive, Light Industry and Science Park II (LISP II), Brgy. Lamesa, Calamba, Laguna, to examine, validate, and verify the eligibility, technical, and financial requirements submitted. After thorough evaluation, Pythos Technology Philippines, Inc. successfully passed the Post Qualification and was thereby declared the Eligible Bidder with the Lowest Calculated and Responsive Bid (LCRB);

CONTRACT AGREEMENT

THIS AGREEMENT made on the 12/20/2024 by and between NATIONAL TOBACCO ADMINISTRATION, with office address at 11th Floor The Upper Class Tower, Quezon Avenue corner Scout Reyes St., Barangay Paligsahan, Quezon City, hereinafter called the "Entity" of the one part, and PYTHOS TECHNOLOGY PHILIPPINES, INC. with office address at No. 3 Mountain Drive, Light Industry and Science Park II (LISP II), Brgy. Lamesa, Calamba, Laguna, hereinafter called the "Supplier" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the "Supply & Delivery of Seventeen (17) Units of Midrange Laptop Computers for the Use of the NTA Central Office and Branch Offices" (PB 2024-04), and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Eighty-Three Thousand Seven Hundred Fifty (P1,083,750.00) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation:
