BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION NO. PB 2024-05

December 20, 2024

WHEREAS, pursuant to the 2016 Revised Implementing Rules and Regulations of the Republic Act No. 9184 (The Government Procurement Reform Act), the NTA Bids and Awards Committee (BAC) caused the PhilGEPS posting through Public Bidding of the project: "Land Development, Office Repair, & Improvement of the NTA Abra Branch Office" on November 26, 2024, with an Approved Budget for the Contract (ABC) in the amount of \$\mathbb{P}\$1,499,780.41;

WHEREAS, on December 05, 2024, the BAC conducted a Pre-Bidding Conference, which was not attended by any interested bidders;

WHEREAS, during the Opening of Bids for the Project: "Land Development, Office Repair, & Improvement of the NTA Abra Branch Office" with Contract ID No. PB 2024-05, conducted on December 17, 2024, at 10:00 A.M., the sole bidder submitted its bid proposal:

1. Sembri Construction

WHEREAS, the prospective bidder successfully passed the Eligibility and Technical Document evaluations using the Pass/Fail criterion. Accordingly, the BAC proceeded with the opening of the Financial Envelopes and tendered a financial proposal:

1. Sembri Construction

WHEREAS, Sembri Construction, offered the amount of ₱1,492,706.37 which is lower than the Approved Budget for the Contract in the amount of ₱1,499,780.41;

WHEREAS, a Bid Evaluation was conducted on December 18, 2024, to determine the completeness of the bid, technical specifications, and whether there were any arithmetical or computational errors in the submitted bid, and the Bid Evaluation Report showed discrepancies in the total bid price of Sembri Construction;

WHEREAS, Sembri Construction was declared as the Single Calculated Bid in the amount of ₱1,492,691.42;

WHEREAS, the BAC conducted a Post Qualification process via a virtual meeting, which took place on December 19, 2024, with the members of the Technical Working Group at Sembri Construction, Ubbog Lipcan, Bangued, Abra, to examine, validate, and verify the eligibility, technical, and financial requirements submitted. After thorough evaluation, Sembri Construction successfully passed the Post Qualification and was thereby declared the Eligible Bidder with the Single Calculated and Responsive Bid (SCRB);

WHEREAS, the Entity invited Bids for certain works, particularly the "Land Development, Office Repair, & Improvement of the NTA Abra Branch Office" (PB 2024-05), and has accepted a Bid by the Contractor for the execution and completion of such Works in the sum of One Million Four Hundred Ninety-Two Thousand Six Hundred Ninety-One and Forty-Two Hundredths (P1,492,691.42) hereinafter called "the Contract Price".
