WHEREAS, the NTA, as the lead agency tasked in promoting the interest of the tobacco growers, has taken a pro-active role by continuously fostering partnership with other industry stakeholders to implement various programs and projects under the STEP towards a thriving local economy, a progressive tobacco industry, and self-sufficient and food-secure communities.

WHEREAS, other industry stakeholders, including the Regional Development Councils (RDCs) of tobacco-growing regions, the League of Municipalities of the Philippines (LMPs) of different chapters, the Provincial Governors, and the National Federation of Tobacco Farmers Association and Cooperatives (NAFTAC) have joined the united call for funding support to implement the STEP, as evidenced by the attached Resolutions/Endorsements.

WHEREAS, the efficient use of funds derived from the collection of tobacco excise taxes, specifically from RA No. 7171 (Virginia tobacco) and RA 8240 (Burley and Native tobacco), as well as the NTA's entitlement to RA No. 4155 (Tobacco Fund), which, per latest certification, amounts to Pesos: Ninety-Eight Billion One Hundred Thirty-Five Million Seven Hundred Ninety-Thousand Two Hundred Seventy-Six & 63/100 (PhP98,135,790,276.63) is critical and indispensable for the sustainable development of the tobacco industry and for the realization of the objectives of the STEP.
